 - * Free State (Lejweleputswa, Matjhabeng, Masilonyana)
 - * North West (Dr Kenneth Kaunda, Ratlou, Moqhaka)
 - ★ Gauteng (City of Johannesburg, Merafong City, West Rand)
- Only Graduates and Diplomats with a full tertiary qualification obtained from an accredited South African university or college will be allowed to apply.
- Students applying for an Internship must have completed their qualification in the field of which they apply for and must NOT have benefitted from a similar programme previously.
- Should an applicant be successful, they will be expected to complete a full medical examination and security screening.
- Students applying for P1/P2 Experiential, must provide a recent letter from the institution indicating the need for P1P2 exposure.

Requirements:

- Certified copy of a valid South African Identity Document (SA citizen).
- Certified copy of qualifications relating to field applying for.
- Brief Curriculum Vitae.
- Proof of residence (water and lights account or a signed affidavit).
- Children of Harmony employees to submit proof of parent's employment (copy of clock card to show industry number) indicate this clearly on your application.
